NORTH CAROLINA PSYCHOLOGY BOARD ANNUAL REPORT June 30, 2020

This report is submitted in accordance with G.S. § 90-270.10. The report covers the activities of the North Carolina Psychology Board for the period of July 1, 2019, through June 30, 2020.

Tonya C. Omar, M.A. and Katrina Brent were appointed to serve until June 30, 2022. Officers for the fiscal year were Robert W. Hill, Ph.D., ABPP, Chairperson and, Helen T. Brantley, Ph.D., Vice-Chairperson.

The Board held three face-to-face meetings and six teleconference meeting, as follows:

A public hearing on proposed changes to the Board's rules was held on September 27, 2019. Three administrative hearings were held during the fiscal year in the following matters: Catherine O'Brien, M.Ed., August 2, 2019; Annette C. Baker, Ph.D., November 8, 2019; and Daniel Edwards, M.S., February 7, 2020.

The following action was taken or confirmed pursuant to G.S. § 90-270.15 and G.S. § 90-270.16:

ASPENSON, DAVID O., Ph.D. - CONSENT ORDER was approved and signed on August 2, 2019. On February 7, 2019, Respondent entered into a Consent Order with the Board. One of the provisions of the Consent Order was for Respondent to undergo a fitness for practice evaluation. Based upon the review of the fitness for practice evaluation, the Board determined at the May 9, 2019 Board meeting that Respondent was not fit to practice psychology and revoked his license. If Respondent were to challenge the Board's determination, he would contend that the fitness to practice evaluation found him fit to practice under reasonable conditions. However, Respondent has decided to retire from practice. Respondent shall voluntarily RELINQUISH his license to practice psychology as of August 2, 2019 and the Board shall accept his relinquishment. The August 2, 2019 Consent Order dissolves, supersedes, and voids any prior action taken by the Board as a result of the Board's determination that Respondent was not fit to practice. Respondent is assessed \$300.00 in costs.

AUSTIN, WILLIAM, Ph.D. - CONSENT ORDER was approved and signed on November 7, 2019. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10) & (a)(19) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 2.06(b) and 6.04(c) of the Ethical Principles of Psychologists and Code of Conduct. Respondent shall complete a minimum of four to six hours of tutorials. Within 30 days of execution of the Consent Order, Respondent shall submit a written plan to the Board in the event that any current or future health issues interfere with his psychology-related responsibilities. The plan shall include, specifically, how he will limit his practice, suspend his practice, or seek consultations, as appropriate. He shall update the plan on a regular basis as his health changes. Respondent shall keep the Board apprised of any action taken against his license to practice psychology in Colorado or in any other state in which he is licensed. Respondent is assessed \$300.00 in costs. This action taken by the Board shall constitute Remedial Action and shall not constitute disciplinary action.

BAKER, ANNETTE, PH.D. – ORDER OF SUMMARY SUSPENSION approved and signed on September 27, 2019. Respondent's license to practice psychology is hereby SUMMARILY SUSPENDED. The suspension is effective on October 15, 2019. The suspension shall remain in effect until the Board issues a Final Decision in this matter or until the parties enter into a Consent Order that is a final determination in this matter.

BAKER, ANNETTE, PH.D. – FINAL DECISION was signed on March 5, 2020 REVOKING respondent's license. Respondent failed to comply with the 2016 Final Decision of the Board, which is a violation of an Order of the Board and violates N.C. Gen. Stat. § 90-270.15(a)(22). Respondent failed to comply with a Board Order to produce records and a response to the complaint filed against her by BP, which is a violation of an Order of the Board pursuant to the Board's authority under N.C. Gen. Stat. § 90-270.9, and violates N.C. Gen. Stat. § 90-270.15(a)(22). Respondent failed to comply with a Board Order to produce records and a response to a complaint filed with the Board against her by AM, which is a violation of an Order of the Board, pursuant to the Board's authority under N.C. Gen. Stat. § 90-270.9, and violates N.C. Gen. Stat. § 90-270.15(a)(22). Respondent failed to comply with a Board Order to produce records and a response to a complaint filed with the Board against her by JP, which is a violation of an Order of the Board pursuant to the Board's authority under N.C. Gen. Stat. 90-270.9, and is a violation of N.C. Gen. Stat. § 90-270.15(a)(22). Respondent is assessed \$300.00 in costs.

BERRY, CYNTHIA, M.A. - CONSENT ORDER was approved and signed on January 8, 2020. The Board's evidence would show that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10) & (a)(14) of the North Carolina Psychology Practice Act, and constitutes violations of Standard 9.08(a) & (b) of the Ethical Principles of Psychologists and Code of Conduct. Respondent contends that her use of the psychological tests in question does not constitute a violation of North Carolina law, or that she violated any of the Standards or Ethical Principles of Psychologists and Code of Conduct. Respondent shall successfully complete a minimum of two to four hours of tutorials. In addition to her current regular supervision, for a period of one year consisting of the completion of at least 20 psychological evaluations, Respondent shall receive face to face supervision with a psychologist at a minimum of one one-hour session per month during any month in which Respondent conducts any psychological

testing. The supervisor will specifically supervise Respondent's psychological testing. Respondent is assessed \$300.00 in costs.

COOPER, CHARLES, Ph.D. - CONSENT ORDER was approved and signed on November 7, 2019. The Board's evidence would show that, during the therapeutic relationship, Respondent did not maintain professional boundaries with Patient X in keeping with ethical practice. Respondent's boundary violations with Patient X resulted in emotional harm to Patient X and negatively impacted Patient X's perception of psychological services provided by Respondent, thus affecting her social functioning and personality issues. Respondent did not document the nature of these boundary violations in Patient X's record, nor did he document any discussions he had with Patient X regarding boundaries or ethical practice. Respondent's evidence would show that he structured the therapy intentionally in ways that Patient X requested and in an attempt to treat Patient X's mental health issues. Respondent has decided to retire permanently and will retire from practice not later than December 31, 2019. Respondent shall RELINQUISH his license to practice psychology and resign from his practice within five business days after transitioning his last long-term patient or on December 31, 2019, whichever comes first, and the Board shall accept his relinquishment. Respondent is assessed \$300.00 in costs.

DAUBS, CARLYN, Ph.D. - CONSENT ORDER was approved and signed on September 27, 2019. Respondent admits that the described conduct if proven at a hearing constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10) & (a)(14) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 9.01(a), 9.02(a), and 9.08(a) of the Ethical Principles of Psychologists and Code of Conduct. Respondent shall successfully complete a minimum of four to six hours of tutorials. For a period of one year, Respondent shall receive face to face supervision with a psychologist licensed in North Carolina at a minimum of one one-hour session for every two weeks of practice of psychology. Respondent is assessed \$300.00 in costs.

EDWARDS, DANIEL, M.S. - FINAL DECISION to deny licensure at the Licensed Psychological Associate level was approved and signed on April 23, 2020.

LEAVER, CAMILLE, M.A. - CONSENT ORDER was approved and signed on January 8, 2020. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10), (a)(11), (a)(15), (a)(17) & (a)(18) of the North Carolina Psychology Practice Act, and Standards 3.04, 3.05, & 6.01 of the Ethical Principles of Psychologists and Code of Conduct. Respondent will voluntarily RELINQUISH her license to practice psychology by no later than February 15, 2020, and the Board shall accept her relinquishment. Respondent shall terminate all of her clients prior to that date and shall transfer clients to other licensed mental health professionals, as appropriate. Should Respondent apply for relicensure in the future, she shall complete a minimum of ten to twelve hours of tutorials prior to applying for relicensure. Following relicensure, Respondent shall abide by the supervision requirements set forth in the Consent Order. Respondent is assessed \$300.00 in costs.

MUHAMMAD, MALIK, PH.D. – CONSENT ORDER was approved and signed on April 23, 2020. Respondent admits that the described conduct violates N.C. Gen. Stat. §§ 90-270.15(a)(10), (a) (14), (a)(15), (a)(16), (a)(17), and (a)(18) of the North Carolina Psychology Practice Act and Standards 6.01, 9.01, 9.02(a) and 9.06 of the Ethical Principles of Psychologist and Code of

Conduct. Respondent's license is REPRIMANDED. Respondent shall complete a six-month independent study. Following completion of the independent study, Respondent shall be supervised for nine months, consisting of 20 psychological evaluations, whichever takes longer to occur. Respondent is assessed \$300.00 in costs.

O'BRIEN, CATHERINE, M.ED. – FINAL DECISION denying Ms. O'Brien licensure at the Licensed Psychological Associate level was approved and signed on September 27, 2019.

RISHER, HOWARD BRANDON. M.A. - CONSENT ORDER was approved and signed on January 8, 2020. Respondent does not admit the described conduct, but Respondent acknowledges that the described conduct would constitute violations of N.C. Gen. Stat. §§ 90-270.15(a)(10), (a)(11), (a)(15), (a)(17), (a)(18) & (a)(20) of the North Carolina Psychology Practice Act, and would constitute violations of Standards 3.04, 3.05, 3.06, 3.08, 6.01, 10.05, & 10.08 of the Ethical Principles of Psychologists and Code of Conduct. Respondent's license is REVOKED, effective January 31, 2020. No later than January 31, 2020, Respondent shall terminate psychological services to all of his patients/clients and shall make provisions for the appropriate transition of his patients/clients to another mental health professional, as appropriate. No later than January 31, 2020, Respondent shall also cease to engage in any other activities that meet the definition of the practice of psychology in N.C. Gen. Stat. § 90-270.2(8), including the supervision of other mental health professionals. Respondent is assessed \$300.00 in costs.

WIENER, DONNA, Ph.D. - CONSENT ORDER was approved and signed on February 7, 2020. Respondent neither admits nor denies that her described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10), (a)(11), (a)(12), (a)(15) & (a)(17) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 3.04 & 6.01 of the Ethical Principles of Psychologists and Code of Conduct. Respondent shall complete a minimum of six to eight hours of tutorials. For a period of eighteen months consisting of 2000 hours of practice in psychology, whichever takes longer to occur, Respondent shall receive face to face supervision at a minimum of one one-hour session per week during any week in which Respondent practices psychology, regardless of the number of hours of practice. Respondent is assessed \$300.00 in costs. This Consent Order does not represent any discipline against Respondent but shall constitute a condition on her license to practice psychology.

During the 2019-2020 fiscal year, the Board:

- reviewed applications and licensed qualified individuals
- reviewed and resolved complaints regarding ethical and legal issues
- amended, repealed and readopted the Board's rules
- implemented responses to COVID-19 pandemic
- increased Board transparency by posting additional information to website
- continued development of an online state exam
- continued development of online license application system
- initiated development of discipline monitoring system
- continued upgrade of IT systems and equipment

In addition to continuing to perform its routine tasks in connection with protecting the public, major objectives for the 2020-2021 fiscal year are as follows:

- continue to respond to COVID-19 pandemic issues
- conduct biennial license renewal process, including enhanced online renewal options
- address budgetary and long-range planning issues
- continue to seek fee increases to enable the Board to fulfill its statutory mandate to protect the public from incompetent, unethical, and unprofessional practice
- adopt, amend, and repeal the Board's rules as necessary
- implement online state exam
- continue development of online license application system
- continue development of discipline monitoring system
- implement PSYPACT interstate license compact
- continue digitizing licensure files
- continue IT systems and equipment upgrade
