ANNUAL REPORT

June 30, 2015

This report is submitted in accordance with G.S. § 90-270.10. The report covers the activities of the North Carolina Psychology Board for the period of July 1, 2014, through June 30, 2015.

Robert W. Hill, Ph.D., ABPP, was appointed to serve an additional term until June 30, 2017. Stacie L. MacDonald, M.A., was appointed to serve until June 30, 2017, replacing Jeffrey M. Lorence, M.A. Officers for the fiscal year were Kristine M. Herfkens, Ph.D., ABPP, Chairperson and Robert W. Hill, Ph.D., ABPP, Vice-Chairperson.

The Board held four regularly scheduled face-to-face meetings and two teleconference, as follows:

February 6, 2015	Greensboro, NC
May 14, 2015	Greensboro, NC

Two administrative hearings were held during the fiscal year in the following matters: David F. Schultz, Ph.D., November 6, 2014; Douglas L. Welsh, M.A., November 6, 2014.

The following action was taken or confirmed pursuant to G.S. § 90-270.15 and G.S. § 90-270.16:

Barnette, Sharon M., M.A., Respondent – CONSENT ORDER was approved and signed on May 14, 2015. Ms. Barnette admits that the described conduct constitutes violations of N.C. Gen. Stat. § 90-270.15(a)(7) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54.2008(h)(3), of the North Carolina Psychology Board rules. Ms. Barnette's license to practice psychology is hereby REPRIMANDED. For a period of two years Ms. Barnette's Board-approved supervisor shall submit a report every six months verifying that Ms. Barnette has received the required supervision based upon the hours she is engaged in activities requiring supervision. Ms. Barnette also must remit \$300.00 in costs.

Buldas, James J. Ed.D., Respondent – ORDER OF SUMMARY SUSPENSION was approved and signed on November 6, 2014. The State Board of Psychology of Ohio indefinitely suspended Respondent's license to practice psychology. Respondent's conduct violates several provisions of the NC Psychology Practice Act and several provisions of the Ethical Principles of Psychologists and Code of Conduct. Based upon the nature of the findings and conclusions by the State Board of Psychology of Ohio, the NC Psychology Board SUMMARILY SUSPENDED Respondent's license to practice psychology.

Collins, Cameron K., Ph.D., Respondent – CONSENT ORDER was approved and signed on August 7, 2014. Respondent's admits that the described conduct was unprofessional in violation of N.C. Gen. Stat. §§ 90-270.15(a)(10) & (a)(17) and Standard 6.01 of the Ethical Principles of Psychologist and Code of Conduct. Respondent must successfully complete a monitoring program and manage her medical condition in accordance with her physician's orders; and she must remit \$300 in costs.

Miller, Nancy L., Psy.D., Respondent – CONSENT ORDER was approved and signed on August 7, 2014. Respondent admits that the described conduct violates N.C. Gen. Stat. §§ 90-270.15(a)(10) (unprofessional conduct) & (a) (14) and Standards 3.05 (a) & 9.01 of the Ethical Principles of Psychologist and Code of Conduct. Respondent must successfully complete tutorials; receive face to face supervision; and remit \$300 in costs.

Schultz, David F., Ph.D., Petitioner – FINAL DECISION to DENY Petitioner's application for licensure at the Licensed Psychologist level was approved on December 16, 2014.

Stanley, Kaden J., Psy.D., Respondent — CONSENT ORDER was approved and signed on May 14, 2015. Dr. Stanley admits that the described conduct constitutes violations of N.C. Gen. Stat. § 90-270.15(a)(10) of the North Carolina Psychology Practice Act, and Standard 8.11 of the Ethical Principles of Psychologists and Code of Conduct. Dr. Stanley's license is CENSURED. He is ordered to successfully complete tutorials and is assessed \$300 in costs.

Trayford, David K., M.S., Respondent – FINAL DECISION was approved and signed on August 7, 2014. Respondent's conduct constitutes violations of N.C. GEN. STAT. § 90-270.15(a)(10), (a)(19), and (a)(22); Standard 3.09 of the *Ethical Principles of Psychologists and Code of Conduct*; Rule 21 NCAC 54 .2002; and the Consent Order Respondent entered into with the Board on July 19, 2012. Respondent's license is REVOKED. He must cease to practice psychology by no later August 29, 2014 and remit \$1,500 in costs.

Welsh, Douglas L., M.A., Petitioner – FINAL DECISION to DENY Petitioner's application for licensure at the Licensed Psychological Associate level was approved on December 16, 2014.

Welser, Richard D., Ph.D., Respondent – FINAL DECISION was approved and signed on August 7, 2014. Respondent's conduct constitutes violations of N.C. Gen. Stat. § 90-270.15(a)(10), (a)(17), (a)(18), and (a)(22); Standards 1.06 and 4.01 of the Ethical Principles of Psychologist and Code of Conduct. Respondent's license is REVOKED. He must cease to practice of psychology within two weeks of receipt of the FINAL DECISION and remit \$300 in costs.

Ziff, David, Ph.D., Respondent – CONSENT ORDER was approved and signed on February 6, 2015. Respondent admits that the described conduct constitutes violations of the 2012 Consent Order and violations of N.C. Gen. Stat. § 90-270.15(a)(7) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104(f), of the North Carolina Psychology Board rules. Respondent's license to practice psychology is hereby SUSPENDED for a period of one year until December 1, 2015. Respondent must submit proper documentation establishing that he has completed all of the required continuing education hours, in compliance with 21 N.C.A.C. 54 .2104, with his application for the 2016-2018 biennial licensure renewal period and remit \$300 in costs.

- published two editions of *psych*NEWS, the Board's newsletter
- provided formal training for a new member
- sought fee increases to enable the Board to fulfill its statutory mandate to protect the public from incompetent, unethical, and unprofessional practice
- developed system to submit complaints through the Board's website
- made Board Actions available through the Board's website
- continued development of an online state exam
- continued development of an online license renewal system
- initiated development of online license application system
- initiated update of Board's website
- continued process to upgrade IT systems and equipment

In addition to continuing to perform its routine tasks in connection with protecting the public, major objectives for the 2015-2016 fiscal year are as follows:

- address budgetary and long-range planning issues
- continue to seek fee increases to enable the Board to fulfill its statutory mandate to protect the public from incompetent, unethical, and unprofessional practice
- continue to publish a newsletter, at least on a semiannual basis
- adopt, amend, and repeal the Board's rules as necessary
- implement requirement for criminal history record check
- continue IT systems and equipment upgrade
- continue development of online state exam
- continue development of online license renewal system
- update of Board's website
