ANNUAL REPORT

June 30, 2019

This report is submitted in accordance with G.S. § 90-270.10. The report covers the activities of the North Carolina Psychology Board for the period of July 1, 2018, through June 30, 2019.

Helen T. Brantley, Ph.D. was appointed to serve additional terms until June 30, 2021. Susan Hurt, Ph.D. and Lisa M. Duck, MPH, were appointed to serve until June 30, 2021. Officers for the fiscal year were Robert W. Hill, Ph.D., ABPP, Chairperson and, Helen T. Brantley, Ph.D., Vice-Chairperson.

The Board held four regularly scheduled face-to-face meetings and one teleconference meeting, as follows:

No administrative hearing was held during the fiscal year.

The following action was taken or confirmed pursuant to G.S. § 90-270.15 and G.S. § 90-270.16:

1. ASPENSON, DAVID O., Ph.D. - CONSENT ORDER was approved and signed on February 7, 2019. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(12), (17), (18) & (22) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 2.06, 3.05, 3.10 & 6.01 of the Ethical Principles of Psychologists and Code of Conduct. Respondent shall complete a fitness for practice evaluation by a Board designated evaluator within 3 months of being providing the name of the evaluator by the Board. Following completion of the fitness for practice evaluation, if the Board determines that Respondent is fit to practice based upon the fitness for practice evaluation, then Respondent may continue to practice under the conditions set forth in the Consent Order, including completing a minimum of three to five hours of tutorials, completing a practice monitoring program for a five year period; remaining in mental health treatment under the care of a licensed mental health professional for a period of five years and remaining under the care of a licensed physician for medication management for a period of five years. The Respondent is assessed \$300.00 in costs. Based upon the review of the Fitness for Practice Evaluation, the Board determined at its May 9, 2019 meeting that Respondent was not fit to practice psychology and REVOKED Respondent's license, pursuant to Roman Numeral III of the Consent Order.

2. BENEDICT, KENNETH B., Ph.D. - CONSENT ORDER was approved and signed on August 2, 2018. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10), (a)(11), (a)(15), (a)(17), (a)(18) & (a)(20) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 3.04, 3.05, 3.06, 3.08, 4.05, 6.01, 10.05, 10.06 & 10.08 of the Ethical Principles of Psychologists and Code of Conduct. The license of the Respondent is hereby REVOKED, effective September 30, 2018. No later than September 30, 2018, Respondent shall also cease to engage in any other activities that meet the definition of the practice of psychology in N.C. Gen. Stat. § 90-270.2(8). Respondent is assessed \$300.00 in costs.

3. DLAMINI-SCOTT, PHOLILE, PSY.D. - CONSENT ORDER was approved and signed on August 2, 2018. Respondent does not contest that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(17) & (a)(18) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 6.01 & 6.02 of the Ethical Principles of Psychologists and Code of Conduct. The license of the Respondent is hereby REPRIMANDED. For a period of at least six months or as long as it takes to complete the conditions set forth in the Consent Order, Respondent shall not conduct any psychological testing. Within the six month period, Respondent shall complete a fitness for practice evaluation. Following completion of the fitness for practice evaluation, if the Board determines that Respondent is fit to practice, Respondent may resume providing psychological testing under probation under the conditions set forth in the Consent Order. Probation shall consist of a period of one year or 1500 hours in the practice of psychology, whichever takes longer to occur. During probation, Respondent shall receive face to face supervision during any week in which Respondent practices psychology. Respondent also shall complete a minimum of four to six hours of tutorials. Respondent is assessed \$300.00 in costs.

4. GILLO, SUSAN, PH.D - CONSENT ORDER was approved and signed on May 9, 2019. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. § 90-270.15(a)(7) of the North Carolina Psychology Practice Act, and Board Rule 21 NCAC 54 .2001 (c)(10). Respondent shall successfully complete a minimum of three to six hours of tutorials. Respondent is assessed \$300.00 in costs. The action taken by the Board in this Consent Order shall constitute remedial action.

5. LARRABEE, MEREDITH, W., PSY.D. - CONSENT ORDER was approved and signed on November 16, 2018. Respondent acknowledges that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(14) & (a)(17) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 6.01, 9.02(a) and 9.08(a) & (b) of the Ethical Principles of Psychologists and Code of Conduct. Respondent's license is hereby REPRIMANDED. Respondent shall successfully complete a minimum of six to eight hours of tutorials. For a period of six months, Respondent shall receive face to face supervision. Respondent is assessed \$300.00 in costs.

6. LAWSON, ROBERT, PH.D. - CONSENT ORDER was approved and signed on November 16, 2018. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10) & (a)(17) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 3.04, 3.05, & 6.01 of the Ethical Principles of Psychologists

and Code of Conduct. Respondent shall successfully complete a minimum of six to eight hours of tutorials. Additionally, for a period of one year consisting of 1500 hours of practice in psychology, Respondent shall receive face to face supervision. Respondent is assessed \$300.00 in costs. The action taken by the Board shall constitute a condition on Respondent's license, pursuant to N.C. Gen. Stat. § 90-270.15(b). This condition shall be lifted upon written notification by the Board of Respondent's successful completion of the terms of this Consent Order. This Consent Order shall not constitute disciplinary action.

7. NORTH, KATHRYN, ED.S. - CONSENT ORDER was approved and signed on May 9, 2019. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.5(e), 90-270.15(a)(7) of the North Carolina Psychology Practice Act, and Board Rules 21 NCAC 54 .2002 (b)(1), (b)(2), & (b)(6), .2006(c), and .2008(e), (f), & (h). The license of the Respondent is hereby CENSURED. Respondent shall successfully complete a minimum of six to eight hours of tutorials. Respondent is assessed \$300.00 in costs.

8. PFLEEGER, SANTINA A., M.A. - CONSENT ORDER was approved and signed on August 2, 2018. Respondent admits that beyond the required reporting deadline, Respondent complied with the Board's continuing education requirements for the 2014-2016 biennial renewal period. Upon entrance of the Consent Order, the Board will accept the RELINQUISHMENT of Respondent's license to practice psychology in North Carolina. Respondent is assessed \$300.00 in costs. The action taken by the Board in the Consent Order shall constitute remedial action.

9. PRICE, DONNA, M.A. - CONSENT ORDER was approved and signed on August 2, 2018. Respondent admits that the described conduct constitutes a violation of N.C. Gen. Stat. § 90-270.15 (a)(7) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104 (k) and (m) of the North Carolina Psychology Board rules. No later than October 1, 2018, Respondent shall complete a minimum of 18 continuing education hours and submit proper documentation to the Board. Once Respondent has completed the continuing education hours and submitted the proper documentation, and, so long as no additional issues related to Respondent's license have come to the Board's attention, the Board will accept the RELINQUISHMENT of her license to practice psychology in North Carolina. The action taken by the Board in the Consent Order shall constitute remedial action. Respondent is assessed \$300.00 in costs.

10. ROWE, JULIE, M.A. - CONSENT ORDER was approved and signed on May 9, 2019. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10), (a)(14) & (a)(15) of the North Carolina Psychology Practice Act, and constitutes violations of Standards 3.05, 9.01(a) & (b) of the Ethical Principles of Psychologists and Code of Conduct. Respondent shall successfully complete a minimum of six to eight hours of tutorials. For a period of one year, Respondent shall receive face to face supervision at a minimum of two one-hour sessions per month during any month in which Respondent practices psychology. Respondent is assessed \$300.00 in costs.

- improved online license renewal system and conducted the biennial renewal of licenses
- launched online supervision report system for license renewal

- increase Board transparency by posting additional information to website
- sought fee increases to enable the Board to fulfill its statutory mandate to protect the public from incompetent, unethical, and unprofessional practice
- sought establishment of inactive licensure status
- continued digitizing licensure files
- continued development of an online state exam
- continued development of online license application system
- continued upgrade of IT systems and equipment

In addition to continuing to perform its routine tasks in connection with protecting the public, major objectives for the 2019-2020 fiscal year are as follows:

- address budgetary and long-range planning issues
- continue to seek fee increases to enable the Board to fulfill its statutory mandate to protect the public from incompetent, unethical, and unprofessional practice
- adopt, amend, and repeal the Board's rules as necessary
- implement online license application system
- implement online state exam
- develop discipline monitoring system
- continue digitizing licensure files
- continue IT systems and equipment upgrade
