

**NORTH CAROLINA PSYCHOLOGY BOARD**  
**Board Action**  
**July 1, 2011 through June 30, 2012**

During the fiscal year July 1, 2011 - June 30, 2012, the following action was taken or confirmed by the North Carolina Psychology Board pursuant to G.S. § 90-270.15 and G.S. § 90-270.16:

Jack P. Burrows, M.A., Respondent – FINAL DECISION was approved on November 14, 2011. Respondent's conduct constitutes violations of N.C. Gen. Stat. §' 90-270.15(a)(7), (a)(10), and (a)(22) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104(m) of the North Carolina Psychology Board rules. Respondent's license is **SUSPENDED INDEFINITELY**. He must meet specified conditions in order to have the suspension lifted, may not engage in activities which constitute the practice of psychology until such time as the suspension is lifted, and remit \$300.00 in costs.

James P. Clemens, M.A., Respondent – FINAL DECISION was approved on November 14, 2011. Respondent's conduct constitutes violations of N.C. Gen. Stat. §' 90-270.15(a)(7), (a)(10), and (a)(22) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104(m) of the North Carolina Psychology Board rules. Respondent's license is **REPRIMANDED**. He must successfully complete tutorials, complete twice the amount of required Category A continuing education hours between October 1, 2010 and October 1, 2012, submit proper documentation establishing that he has completed all of the required continuing education hours along with his renewal application for the next two renewal cycles, and remit \$300.00 in costs.

Denise Dulken, M.A., Respondent – **CONSENT ORDER** was approved on July 13, 2011. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(5), (a)(7) & (a)(22) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104(d), (f) & (m) of the North Carolina Psychology Board rules. Respondent's license is **REPRIMANDED**. She must successfully complete tutorials, submit proper documentation establishing that she has completed all of the required continuing education hours along with her renewal application for the next two renewal cycles, and remit \$300.00 in costs.

Christopher L. Edwards, Ph.D., Respondent – **CONSENT ORDER** was approved on July 13, 2011. Respondent agrees that the described conduct constitutes violation of N.C. Gen. Stat. §§ 90-270.15(a)(7) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104(d), (f), (g) & (m) of the North Carolina Psychology Board rules. Respondent's license is **REPRIMANDED**. He must successfully complete tutorials, complete twice the amount of the required Category A continuing education hours and submit proper documentation establishing that he has completed all of the hours along with his renewal application for the next two renewal cycles, and remit \$300.00 in costs.

Michael C. Hewett, Ph.D., Petitioner – FINAL DECISION to DENY Dr. Hewett's application for licensure at the Psychologist level was approved on September 22, 2011.

Brad H. Mahan, M.S., Petitioner – FINAL DECISION to DENY Mr. Mahan’s applications for licensure and certification for health services provider certification at the psychological associate level was approved on July 13, 2011.

Judith C. Milakovich, Ph.D., Respondent – CONSENT ORDER was approved on April 26, 2012. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10) of the North Carolina Psychology Practice Act, and Standard 9.01(b) of the *Ethical Principles and Code of Conduct* (American Psychological Association, 2002). The action taken by the Board constitutes REMEDIAL action. Respondent must successfully complete tutorials and remit \$300.00 in costs.

Nikki Orndoff, M.A., Respondent – CONSENT ORDER was approved on July 14, 2011. Respondent admits that she unintentionally violated N.C. Gen. Stat. § 90-270.15(a)(7) of the North Carolina Psychology Practice Act due to her failure to provide the necessary continuing education certificates to the Board under 21 N.C.A.C. 54 .2104(m) of the North Carolina Psychology Board rules. The action taken by the Board constitutes REMEDIAL action. Respondent must successfully complete tutorials, submit proper documentation establishing that she has completed all of the required continuing education hours along with her renewal application for the next two renewal cycles, and remit \$300.00 in costs.

Elizabeth Pedersen, Ph.D., Respondent – CONSENT ORDER was approved on January 25, 2012. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(5) & (a)(7) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104 (d), (f) & (m) of the North Carolina Psychology Board rules. Respondent provided the Board with documentation establishing that she had the required documentation and completed the required continuing education during the 2008-2010 biennial licensure renewal period. The action taken by the Board constitutes REMEDIAL action. Respondent must successfully complete tutorials; between October 1, 2010, and October 1, 2012, complete twice the amount of the required Category A continuing education hours and submit proper documentation establishing that she has completed all of the hours along with her renewal application for the 2012-2014 biennial renewal cycle; submit proper documentation establishing that she has completed all of the hours along with her renewal application for the 2014-2016 biennial renewal cycle; and remit \$300.00 in costs.

Andrew A. Proffer, Ph.D., Respondent – CONSENT ORDER was approved on September 22, 2011. It is stipulated by Respondent and the Board that the Board finds that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(10), (a)(18), & (a)(20) of the North Carolina Psychology Practice Act, and Standards 3.04, 3.05(a), 3.08, 6.01 and 10.08(a) of *the Ethical Principles of Psychologist and Code of Conduct* (American Psychological Association 2002). Respondent’s license is REVOKED effective November 15, 2011, and he shall remit \$300.00 in costs.

Anna Szajnert-Klein, Petitioner – FINAL DECISION to DENY Ms. Szajnert-Klein’s application for licensure at the Psychological Associate level was approved on September 22, 2011.

Deborah C. Tyler, Ph.D., Petitioner – FINAL DECISION to DENY Dr. Tyler’s applications for licensure and certification for health services provider certification at the psychologist level was approved on July 13, 2011.

David Ziff, Ph.D., Respondent – CONSENT ORDER was approved on April 26, 2012. Respondent admits that the described conduct constitutes violations of N.C. Gen. Stat. §§ 90-270.15(a)(5) & (a)(7) of the North Carolina Psychology Practice Act, and 21 N.C.A.C. 54 .2104 (f), (k) & (m) of the North Carolina Psychology Board rules. Respondent provided the Board with documentation establishing that he had the required documentation and completed the required continuing education during the 2008-2010 biennial licensure renewal period. The action taken by the Board constitutes REMEDIAL, but not disciplinary, action. Respondent must successfully complete tutorials; between October 1, 2010 and October 1, 2012, complete twice the number of continuing education hours as required in 21 NCAC 54 .2104 and submit proper documentation establishing that he completed all of the hours along with his renewal application for the 2012-2014 biennial renewal cycle; submit proper documentation establishing that he has completed all of the required continuing education hours along with his renewal application for the 2014-2016 biennial renewal cycle; and remit \$300.00 in costs.
