PROFESSIONAL ENTITY RENEWAL INSTRUCTIONS

January 1, 2022 – December 31, 2022

Pursuant to § 55B-11, renewal is due by March 1, 2022 for your Certificate of Registration of the Professional Entity (i.e. Professional Corporation OR Professional Limited Liability Company [PLLC]). You may renew the certificate of registration either ONLINE or by MAIL (if postmarked by 3/1/22).

To renew the Certificate of Registration ONLINE, please go to the Board website (www.ncpsychologyboard.org), click on the "Renew A Professional Entity" tab, and then click on the Renew Online link. In order to renew online. you must pay the \$25 renewal fee by credit/debit card by March 1, 2022.

You <u>may</u> renew your Certificate of Registration <u>by mail</u> by returning to the Board office the completed <u>2022 Renewal</u> Application for Professional Corporation or PLLC (which can be found on the Board's website) AND the required \$25 fee (check or money order) if postmarked by March 1, 2022. (a postmark, but not a metered date or tape, will be considered sufficient in meeting a deadline)

If you do NOT renew online by March 1, 2022 OR submit the completed 2022 Renewal Application for Professional Corporation or PLLC form and \$25 fee postmarked by March 1, 2022, the Certificate of Registration will automatically be suspended, and the North Carolina Secretary of State Corporation Division will be notified. However, the entity may be reinstated within the calendar year by sending a completed Renewal Application form along with the required payment of \$35, which includes an additional \$10 penalty.

The Board may take disciplinary action if a licensee engages in fraud or deceit in securing or attempting to secure or renew a Certification of Registration. Failure to complete the renewal process by the established deadline and in the required format may result in a delay in certificate of registration renewal, the assessing of a penalty fee, or suspension of the Certification of Registration.

SUSPENDED CERTIFICATION OF REGISTRATION	If your completed professional entity renewal application (including \$25 renewal fee payment) is not postmarked or made online by 3/1/22, the entity's Certification of Registration will be automatically suspended pursuant to § 55B-11, and the North Carolina Secretary of State, Corporation Division, will be notified. However, the entity may be reinstated within the calendar year by submitting the required Renewal Application form and the required \$35 fee, which includes a late renewal fee of \$10.
CHANGES OF INFORMATION	If you renew online and <u>any</u> contact information for your Professional Entity has changed, please email the new information to the Board at <u>info@ncpsychologyboard.org</u> . The email MUST contain the name of your Professional Entity in order to be processed. Otherwise, the changed information cannot be processed.
